Ihor Bardyn is the Director of the Canada-Ukraine Parliamentary Program, an internship program for university students from Armenia, Azerbaijan, Georgia and



Ukraine in the Canadian House of Commons. He is the founder (in 1990) of the Canada-Ukraine Parliamentary Program, a co-founder of the World Congress of Ukrainian Jurists (in 1991) and co-founder of the Metropolitan Sheptytsky Institute Foundation (in 1990). From 2003 to 2010 he served on the Council of Administration of St. Paul University in Ottawa. Currently he is the Co-Chair of Trust Advisory Committee of the John Yaremko Chair of Ukrainian Studies at the University of Toronto, a Director of the Ukrainian Legal Foundation in Kyiv, and President of the Chair of Ukrainian Studies Foundation of Toronto. was the country representative AMNESTY International to Ukraine in the investigation of the imprisonment of Stefan Khmara (in 1990-1991). In 1999 he was recognized with the award of the Silver Medal of Eternal Flame by the Conference of PLAST Scouting Organizations in recognition of his work on behalf of Plast and volunteer service to communities and in 2003 with the Queen's Commemorative Medal on Her Majesty Queen Golden Elizabeth Π Jubilee, contribution to Canada. Currently serves as Director of the Canada-Ukraine Parliamentary Program and President of Katedra Foundation in Toronto. He is a member of the Atlantic Council of Canada.

Taras Berezovets is a spin doctor and owner of Berta Communications strategic consulting company in Kyiv, Ukraine. Since 2007 has also been operating one of Ukraine's leading think tanks Polittech. Taras Berezovets was born in Kerch, Crimea in 1975. He graduated from the Institute of Journalism of National Taras Shevchenko University of Kyiv in 1997. In 2003 he graduated from the Royal College of Defense Studies, London, UK and in 2004 earned



an M.A. in International Studies from King's College, London, UK. During his studies at the RCDS Mr. Berezovets was a member of a multinational group (more than 50 nationalities), consisting of the prominent international leaders, including high ranking officers, diplomats and members of parliament. In September-October 2003 he and 10 of his colleagues visited India, Sri Lanka and Pakistan where they met state top officials. On his return to the UK Mr. Berezovets presented a research paper on the India-Pakistan nuclear conflict. In his professional career, since 1997 Mr. Berezovets has held numerous positions. In 1997-98 he was press secretary to the permanent representative of the President of Ukraine to Verkhovna Rada (Parliament) of Ukraine Roman Bezsmertnyi. From June 1998 to September 1999 he held the position of senior consultant to the National Institute for Ukrainian and Russian Relations under auspices of the National Security and Defense Council of Ukraine. From 1999 to 2002 and again from 2004 until mid-2005 Berezovets was a chief consultant and later the state expert in the foreign security department of the National Security and Defense Council of Ukraine. From 2000 until 2002 he worked as a member to the Interdepartmental group of the National Security Council's secretaries of Ukraine, Russia, Poland and Belorussia. During his posting in the national security sphere his main responsibilities were to deal with the NATO and EU enlargement. Since 2007 Mr. Berezovets has acted as consultant to the political bloc BYUT of ex-Prime Minister of Ukraine Yulia Tymoshenko and her government. In Yulia Tymoshenko's presidential campaign 2009-2010 he was responsible for PR campaign and special projects. He has also been Yulia Tymoshenko's unofficial English speaking speaker for more than 2 years. He maintains blogs on Ukraine's most popular web sites Ukrainska Pravda http://blogs.pravda.com.ua/authors/berezovets/ and Korrespondent http://blogs.korrespondent.net/celebrities/blog/tberezovets/. He is the author of a monograph 'Political Advertising and Problems of Shaping Image of a Political Leader in Ukraine' (2002) and of a research paper 'A controlled media environment: The propagandist component of counter-terrorist operation after 9/11 in the media of leading countries of the coalition" (2003, UK), as well as of a practical guide 'Political Consulting in Ukraine' (2005). Nazar Bobitski is a Ukrainian diplomat with more than 10 years of professional experience in Foreign Service. His latest position in the Service was chef de cabinet of Deputy Foreign Minister of Ukraine. Previously Nazar Bobitski held posts at the Mission of Ukraine to the European Union in Brussels where he was closely involved in several high-profile negotiations on key EU-Ukraine agreements,



including preparation and launch of talks on the EU-Ukraine Association Agreement, the development of the current framework for EU-Ukraine institutional cooperation - the Association Agenda, dialogues on a number of regulatory issues. Reflecting on his experience with EU-Ukraine relations, Nazar Bobitski is an author of a number of publications in the Ukrainian and European scholarly journals on the current issues of EU foreign policy and European integration of Ukraine. A graduate of Ivan Franko National University of Lviv and the University of Amsterdam in International Relations and International Law, Nazar Bobitski participated in the Canada-Ukraine Parliamentary Program in 1994. Currently Nazar Bobitski is on academic leave from the Foreign Ministry of Ukraine to pursue postgraduate LL.M. studies King's College, University of London.

Nazar Fedorchuk graduated from the law faculty of Ivan Franko National University of Lviv in 2001 and from University of Oxford (Great Britain) in 2004. In 2002 he started working on a comparative research in the field of criminal justice, defended his thesis and received a Ph.D. degree in 5 years.



the work of the Criminal Justice Chair as an assistant professor. From summer 2007 Nazar Fedorchuk works as a Legal Specialist of the U.S. Department of Justice OPDAT program. He directly deals with the issues of the criminal justice system reform and anti-corruption, including drafting work of the new Criminal Procedure Code of Ukraine, Law on Procuracy and other related laws. Nazar Fedorchuk has six published papers and a book on the protection of victims in English-American and Ukrainian legal systems.

Dr. Paul Chaisty received his doctorate in Politics at the University of Leeds, and was a British Academy Post-Doctoral Research Fellow at St. Antony's (1997-2000). He taught Politics at the Universities of Leeds, Royal Holloway and East London, and was the Politics Tutor at Pembroke College, University of Oxford, from 2002 to 2005. Dr. Chaisty has been the University Lecturer in Russian Government since September 2005 and presently is the Director of the Russian and Eurasian Studies Centre of St. Antony's College. Dr. Chaisty's research interests are mainly in the area of Russian politics, and in particular political institutions. He has written on legislative and constitutional politics in post-communist Russia. Publications: Legislative Politics and Economic Power in Russia (Palgrave, 2006); articles in the journals Europe-Asia Studies, The Journal of Legislative Studies, Legislative Studies Quarterly and Party Politics; chapters in edited works on Russian politics by Archie Brown, Alex Pravda and Neil Robinson.

Since 2002, Dr. Olexiy Haran is Professor of Comparative Politics and the Founding Director of the School for Policy Analysis at the University of Kyiv-Mohyla Academy. He is a member of a Washington-based Program on New Approaches to Research



and Security (PONARS-Eurasia), and he serves on the advisory board of Demokratizatsiya. The Journal of Post-Soviet Democratization (Washington, DC). Olexiy Haran graduated from the Department of International Relations, National Taras Shevchenko University of Kyiv in 1981, received his kandydat degree in International Relations in 1985 and doctor degree in Contemporary History in 1996. In 1991 94, he was the Dean and organizer of the Faculty of Social Sciences (Economics, Political Science, Sociology, and History) at the reborn University of Kyiv Mohyla Academy (UKMA). From December 2004 to October 2006, he served as the Eurasia Foundation's Regional Vice President for Ukraine, Belarus, and Moldova. Dr. Haran is the author of books To Kill the Dragon: From the History of Rukh and New Political Parties of Ukraine (1993) and Transatlantic Debates: The Turn of Western Europe to Détente and the Position of the USA (1990), editor of The Multi Party System in Ukraine (1991), Ukraine in Europe: Questions and Answers (2009) and co editor of The Ukrainian Left: Between Leninism and Social Democracy (2000) and Russia and Ukraine: Ten Years of Transformation (Moscow 2003). His comments appeared in The New York Times, The Financial Times, The Economist, Gazeta Wyborcza etc.

Adrian Karatnycky is a non-resident Senior Fellow at the Atlantic Council's Program on Transatlantic Relations and Managing Partner of Myrmidon Group LLC, a New York based consultancy that works with investors

and corporations seeking entry into the complex emerging markets of Ukraine and Eastern Europe. He is a founder and co-director of the Ukrainian-Jewish Encounter. From 1993 until 2004, he was President and executive Director of Freedom House, during which he developed programs of assistance to democratic and human rights movements in Belarus, Serbia, Russia, and Ukraine. At Freedom House he devised a range of long-term comparative analytic surveys of democracy and political reform. For twelve years he directed the benchmark survey Freedom in the World and was co-editor of the annual Nations in Transit study of reform in the post-Communist world. He is a frequent contributor to Foreign Affairs, Newsweek, the Washington Post, the Wall Street Journal, the Financial Times, the International Herald Tribune, and many other periodicals. He is a co-author of three books and co-editor of eight books on Soviet and post-Soviet themes.

Anzhela Yevgenyeva is a DPhil student at the University of Oxford (Law Faculty, St Hilda's College) and a scholar of the Oxford University Centre for Business Taxation. She teaches EU law and European tax law for several University colleges. Anzhela obtained law degrees with distinction from the University of Oxford (MSt) and the National University of Kyiv Mohyla



Academy (MA and BA). Her professional experience involves a mixture of advisory practices, ranging from the tax litigation practice at a City law firm to policy consultancy at the Ukrainian Parliament. Anzhela worked as an editor for the Oxford University Commonwealth Law Journal (2008-09) and the Parliament Journal (2003-09). She is a President of the OUUS and a DPhil representative at the Board of the Faculty of Law and the Faculty's Graduate Studies Committee.

Dr. Nazar Kholod is an independent scholar whose work focuses on economic policy, political economy and government regulation of income distribution in the transition countries of Central and Eastern Europe. Nazar Kholod worked as a research analyst at the Peterson Institute for International Economics (Washington, DC). Prior he was an associate professor at the Department of Economics



and International Economy at Ivan Franko National University of Lviv. Dr. Kholod received two research fellowships sponsored by the U.S. Department of State. He was a visiting scholar at the Center for Russian, East European, and Central Asian Studies, University of Washington (Regional Scholar Exchange Program) in 2003 and Fulbright-Kennan scholar at the Woodrow Wilson International Center for Scholars (Fulbright Senior Scholar Program) in 2006. Kholod is the author of Income Distribution and Poverty in Transitional Countries (Lviv University Press, 2009) and numerous articles on macroeconomic policy in transition countries of Eurasia. He earned his Candidate of Science and Doctor of Science degrees in economics from Ivan Franko National University of Lviv, Ukraine.

Syitlana Kobzar is a Gates Scholar who has recently submitted her Ph.D. at the Department of Politics and International Studies at the University of Cambridge. In her doctoral work, she analyses how the 'idea of Europe' has developed in the Ukrainian discourse on foreign policy during the Kuchma Presidency. While pursuing her Ph.D., Svitlana has conducted additional research projects with several think tanks and academic



institutions and presented her findings to policy officials. As the recipient of the Kinney Research Grant, she has researched Ukraine's Judicial Reform at Harvard University and presented her findings at the Hawaii International Conference on Social Science. Svitlana has also received support from the German Council on Foreign Relations, the Institute for International Relations in Prague and the Italian Institute for International Political Studies to publish her research projects that focus on Ukrainian foreign policy and EU democracy promotion. Since 2009, Svitlana has worked as an Associate Analyst at RAND Europe where she worked on several projects for the European Commission.

Iaroslav Kovalchuk is a Ph.D. Scholar at the University of Algarve (Portugal) through Erasmus Mundus Program for 2010-2013. He is working on the thesis in the sphere of political linguistics concentrating on the psycholinguistic techniques that enable politicians to manipulate the public opinion of the audience through certain peculiarities of their political speeches. Prior to getting Erasmus Mundus Scholarship, in



2009 Iaroslav graduated from National University of Ostroh Academy with a Master's degree in English and Literature. In 2009-2010 he worked as a lecturer at Ostroh academy, at the same time studying at the Economics department of the latter with further obtaining B.A. in Finances in 2010. In 2008 he initiated creation of Active Youth NGO and was elected its head. In 2009 he became a member of public experts group at the Department of Civil Service in Rivne region. In 2010 he worked as an interpreter for OSCE/ODIHR observers' mission during presidential elections in Ukraine. As a freelance journalist Iaroslav published a number of articles in the papers The Day (Ukraine), New Pathway (Canada), Svoboda (USA), Ukrainian News (Canada) etc. He was a Canada Ukraine Parliamentary Program participant in 2008 and a coordinator of the Program in 2009.

Anton Krasun received his B.A. Sociology at Lviv Polytechnic National University. Thanks to the U.S. Department of State fellowship he studied at Troy University in the United States. He was an intern at the Parliament of Ukraine and Konrad Adenauer Stiftung in 2009. Nowadays Anton is pursuing M.Sc. in Sociology at the University of



Oxford and serving as the Secretary for International Relations at Oxford University Ukrainian Society. He is interested in the topics of voting behaviour, electoral sociology, centre-periphery governmental relations, regionalism, and politics of memory.

Serhiy Kovalchuk is a doctoral student in Curriculum Studies and Teacher Development and Comparative, International, and Development Education at Ontario Institute for Studies in Education of the University of Toronto.

Serhiy received his B.A. in Applied Linguistics from Lesya Ukrainka Volyn National University and his M.A. in Social Foundations of Education from



Eastern Michigan University. In 2007-2008, Serhiy served as an educational project manager at the Volyn NGO "Nasha Sprava" and worked as an academic exchange and research specialist at the Office of International Affairs of the Volyn National University. In his studies and research, Serhiy focuses on democratic citizenship education and teacher preparation programs in post-Soviet countries, foreign language policies in a globalized world, and comparative studies of education policy and curriculum in communist and capitalist states.

Nadiya Kravets is a finishing doctoral student at the University of Oxford (2007-2011),
Department of Politics and International Relations, St.
Antony's College, working on Ukraine's foreign and security policy. Her doctoral research has been funded by the IREX Title VIII program and the Open



Society Foundation. Aside from research activities, she is also a tutor in International Relations for Oxford undergraduate and visiting students. Yuriy Lukanov graduated from National Taras Shevchenko University of Kyiv and since 1982 has worked as a journalist and



since 2002 as an independent journalist. Currently he is Head of the Kyiv Independent Media Trade-Union. In 1990 he created and headed the press office of the People's Movement of Ukraine "Rukh Press" which played a crucial role in the referendum on Independence of Ukraine on December 1, 1991. He is the author of numerous books among them "The Third President. Political Portrait of Leonid Kuchma" and "European Fireworks", books of political epigrams and travel notes through six European countries. A filmmaker, he is the author and producer of the historical film "Three Loves of Stepan Bandera". "Who are you, Mr.Jacky?" and the most recent film dedicated to the Ukrainian dissident and journalist Valeriy Marchenko. Lukanov has co-written the ten series documentary "NATO: Friend of Foe?" In 2001 he prepared the visit of Pope John Paul II to Ukraine, as consultant to the Press Service of the Ukrainian Catholic Church in Ukraine. Brigid McCarthy is a freelance radio reporter based in Washington, D.C. She just returned from a year in Kyiv, where she produced stories about



different aspects of life in Ukraine for the foreign affairs program, "The World." Before that, she was a producer at National Public Radio, from 1989-2008.

Taras Kuzio is an inaugural Austrian Marshall Plan Foundation Fellow at the Center for Transatlantic Relations, School of Advanced International Studies, Johns Hopkins University. He has been a Visiting Professor at the Institute for European, Russian and Eurasian Studies, Elliott School of International Affairs, George Washington University and Senior Research Fellow in the Centre for Russian and East European Studies at the University of Birmingham.

Wolchik and Jane L. Curry eds., Central and East European Politics: From Communism to Democracy, Second Edition (Banham, MD: Roman and Littlefield, 2011). He has authored over 60 scholarly articles on postcommunist and Ukrainian politics, and nationalism in Europe, and has guest edited 6 special issues of academic journals, including a recent issue of Communist and Post-Communist Studies on 'Communist Successor Parties in Central-Eastern Europe and Eurasia'. He is the editor of the bi-monthly Ukraine Analyst. Taras Kuzio received a B.A. in Economics from the University of Sussex, an M.A. in Soviet Studies from the University of London and a Ph.D. in Political Science from the University of Birmingham, England. He was a Post-Doctoral Fellow at Yale University.

Lyubov Margolina is a Director in Ukraine for the Ukraine-Canada Building Democracy Project the main goal of which is to develop and introduce courses on democracy into universities and colleges of Ukraine. Since 2010, she has been teaching civic education and

Prof. Oxana Pachlovska, Slavist and Italianist, holds the Chair of Ukrainian Studies within the Department of European, American and Intercultural Studies at the University "La Sapienza", Rome. As an expert in Slavonic



studies, she is particularly keen on promoting Ukrainian studies in Western Europe through a number of articles, papers and essays. Her interests centre on the history of Ukrainian Literature - both ancient and modern - viewed as the meeting-point of a "Humanistic" West and a "Byzantine" East. She is also devoted to highlighting the major issues concerning the crucial transition towards democracy within East Central Europe in light of an enlarged EU, the construction of the Historical Memory and of the Idea of Europe in Ukrainian, Polish and Russian Cultural Tradition. Among her publications worth being mentioned are Civiltà letteraria ucraina (Roma: Carocci Editore, 1998), the first comprehensive study in the West after the fall of the Berlin Wall investigating the history of Ukrainian literature from its early origin to modern times, and Ave, Europa! He is also a member of the Social Studies Faculty of Oxford University. Over many years, he has served as a consultant to official and parliamentary bodies on Russia and Ukraine. Between 1998-2000, he was a Specialist Adviser to the House of Commons



Defence Committee and, between 1983-85, Director of Studies of the Royal United Services Institute for Defence Studies. He is the author of over 100 publications on Russia, Ukraine and European security. Born in New York in 1951, Mr. Sherr holds British and US citizenship. He graduated from Montclair High School (NJ) in 1969 and in 1974 received a B.A. with Highest Honours from Oberlin College. Before 1992, Mr. Sherr was the author of a number of articles and monographs on Soviet military doctrine and policy, as well as Soviet Power: The Continuing Challenge (RUSI/Macmillan, 1987/1991). He also advises NATO, the MOD and the House of Commons Foreign Affairs and Defence Committees on the security policy of the Russian Federation. He has delivered presentations at NATO Winter Academies (Moscow, Ekaterinburg), the first (1997) and second (1998) official NATO-Russian workshops in Moscow, the 2004 defence reform seminar of the NATO-Russia Council and at a number of semi-official and unofficial forums in Moscow, St Petersburg, Veliki Novgorod and Volgograd. He has written for Nezavisimaya Gazeta, Izvestiya, Pro et Contra and Russia in Global Affairs (including 'Russiya i Zapad: Pereotsenka', March-April 2008). His last Defence Academy monograph, Russia, Russia and the West: A Reassessment was published in January 2008. Mr. Sherr is also a member of the Valdai Club and attended the 2008 and 2009 sessions. Rukh holds an observer status in the European People's Party. Borys Tarasyuk is the Founder and Director of the Institute for Euro-Atlantic Cooperation, an independent think-tank. He is a member of the Board of Trustees at the International Renaissance Foundation (Soros Foundation in Ukraine) and of the National University Kyiv Mohyla Academy. Borys Tarasyuk stood at the roots of formation and further realization of Ukraine's relations with Russia, the United States, Hungary and Poland, Romania and Moldova, Baltic and Nordic States, Latin America and the Black Sea region, the European Union and NATO, CIS and GUAM. In 1993 Ambassador Tarasyuk managed to forge the unanimous support of the UN Security Council for Ukraine in the dispute with Russia over the Ukrainian port city of Sevastopol. He was one of the key figures in negotiations of unprecedented complexity over the fate of Ukraine's nuclear arsenal (world's third largest), the Black Sea Fleet and conventional armaments. His efforts to activate the significant peacekeeping potential of Ukraine in combination with active diplomacy transformed Ukraine into a recognized contributor of European security and stability. In 1997 he was a winner of the national nomination "Diplomat of the Year", is decorated with the highest state awards of Argentina, Brazil, France, Lithuania, Poland, Portugal and Sweden and is the full cavalier of the Merit State Order of Ukraine, Polish award «Honorary Decoration Bene Merito» (2009).

Bohdan Vitvitsky is a highly decorated U.S. federal prosecutor. He has also written on law, philosophy and history, and he has taught or guest lectured at Columbia, Harvard, Pittsburgh, Rutgers and other universities. In 1992 he was one of the organizers of the first international conference of Ukrainian lawyers in Kyiv



and delivered a keynote address on the rule of law. Between 2007 and 2009, he served as a Resident Legal Advisor at the U.S. Embassy in Kyiv where he was involved in implementing a large anti-corruption project. He holds a Juris Doctor and a Ph.D. in philosophy from Columbia University in New York.

Dr. Sarah Whitmore is a Senior Lecturer in Politics at Oxford Brookes University and Honorary Research Fellow at the Centre for Russian and East European Studies at the University of Birmingham. After graduating in 1993, Sarah spent two years teaching English at schools in Kyiv, Ukraine before returning to the UK to



undertake postgraduate study on Ukraine. She defended her Ph.D. at the University of Birmingham in 2002, which investigated the extent of institutional development of the Verkhovna Rada 1990-2000, which won the Ashley Prize for the Best Ph.D. in the Social Sciences. Thereafter she held an ESRC postdoctoral fellowship at the same institution before taking up her post in the Department of Politics and International Relations at Oxford Brookes in 2003. Sarah is the author of a monograph State Building in Ukraine: The Ukrainian Parliament, 1990-2003 (London and RoutledgeCurzon, 2004) and a number of articles in peerreviewed journals, most recently The Journal of Legislative Studies and Europe-Asia Studies. She has acted as a consultant on Ukrainian domestic politics to governmental and nongovernmental bodies including the Foreign and Commonwealth Office, the U.S. Department of State and the Westminster Foundation for Democracy. Her research interests centre on the evolution of representative institutions and their significance in structuring power in post-Soviet states. Her recent ESRC project 'Parliamentary oversight in Russia and Ukraine' examined the way formal institutions interact with informal practices in the post-Soviet neopatrimonial state and the implications this has for the political system. These themes are being expanded in a current paper on 'dominant' parties and their role in authoritarian reproduction in Russia and Kazakhstan.

Dr. Kataryna Wolczuk is Deputy Director of the Centre for Russian and East European Studies, the University of Birmingham. She specializes in East European politics and has studied the dynamics of state-building in Ukraine and as well as issues of nationhood and national identity in post-communist Europe. She also conducted research on Ukrainian-



Polish relations in the context of EU enlargement and, more recently, on relations between Ukraine and the enlarged EU. She is currently conducting an international collaborative research project on relations between the EU and the post-Soviet countries within the framework of the European Neighbourhood Policy and the Eastern Partnership (with Dr. Laure Delcour, IRIS, France). Dr. Wolczuk contributed to numerous policy-related initiatives and advised a number of UK governmental bodies, international organizations and think-tanks on East European politics, the consequences of EU enlargement and the relations between the EU and its eastern neighbours. She has extensive media experience, including radio and TV interviews, as well as publications in the British and international press. Her publications include The Moulding of Ukraine: The Constitutional Politics of State Formation (2002), Ethnic Diversity, Muticulturalism and Xenophobia in post-Communist Societies, a special issue of Nationalities Papers (2008) (edited with G. Yemelianova), the Chaillot Paper 'Quo Vadis Ukraine?' (co-authored). She has recently been acting as an expert on the EU's Eastern Neighbours to the Committee of Foreign Affairs, the European Parliament.

Oleksandr Zhurakovskyi was born in 1986 in Dnipropetrovsk, Ukraine. He received his B.Sc. and M.Sc. degrees in Chemistry from Dnipropetrovs'k National University. Andrew Wilson (Ph.D., London School of Economics) is a Senior Policy Fellow at the European Council on Foreign Relations, Reader in Ukrainian Studies at the School of Slavonic and East European Studies (University College London), and Honorary Fellow of the Royal Institute of International Affairs. Dr. Wilson's research interests include politics and culture in independent Ukraine, and comparative politics of post-Soviet democracy, particularly its corruption by so-called 'political technology.'

Olha Zakrevska is a financial analyst with a keen interest in socially sustainable business development and investment analysis. She completed a Master's program in Economics, Concentration in Finance, at American University in Washington, DC, USA under the Fulbright Graduate Program and currently works for a private equity company in DC.

Serget Zhuk is an Associate Professor of Russian and East European History at Ball State University, Muncie, Indiana. D. dissertation in US history in 1987, taught US history and a history of Western Civilization at Dnipropetrovs'k National University in Ukraine.

Andriv Kulykov was born in 1957 in Kyiv, Ukraine. He graduated from the Department of International Relations of National Taras Shevchenko University of Kyiv in 1979 to start working for "The News from Ukraine" weekly in Kyiv as a reporter. In 1992, he left the position of Deputy Editor-in-chief of this



publication for the job of Producer (later Senior Producer) of the BBC World Service Ukrainian Section in London, UK where he worked until 1995. From 1996 to 2000 he held a number of editorial jobs at Ukrainian TV channels and productions (IMC Internews, 1+1, Novyi Kanal) and presented TV news and a talk show (Novyi Kanal, STB). From 2000 to 2005 he worked as a Producer for the BBC World Service Ukrainian Section in London. In 2005-2007 he was a key expert for the "Media Skills Development" Project (BBC-TACIS-EU) in Ukraine. Since 2007 Andriy presents the Svoboda Slova (Freedom of Speech) talk show on a Ukrainian television channel, ICTV. In 1995-2006 Andriy Kulykov conducted a number of trainings for BBC stringers and local journalists in Ukraine, Azerbaijan, and Georgia. In 2006-2010 he lectured at Institute of Journalism, National Taras Shevchenko University of Kyiv, teaching radio skills. He authored a number of articles in Ukrainian press and university publications on mass media and current affairs, specifically where interethnic relations and issues of multiculturalism are concerned.

Giorgi Vashadze was born in 1981, in Tbilisi, Georgia. In 2004 he graduated from Iv.

Javakhishvili Tbilisi State University, Faculty of Law. In 2003 he obtained Bachelor degree in Public Administration at the Georgian Technical University and Master's degree in 2005. In 2006 he was involved in a training



program - International Relations and National Security Issues, administrated by Georgian Foundation for Strategic and International Studies (GFSIS). Giorgi Vashadze also graduated from Executive Program for Leadership Development at Harvard Business School in 2010. Since 2006 he is the Head of Civil Registry Agency of Ministry of Justice of Georgia. From March 2010, he was also appointed as Deputy Minister of Justice. From 2001 to 2005 Giorgi Vashadze worked at the following positions: Deputy Chairman of Civil Registry Agency (2005-2006); Chief of the Tbilisi, Chugureti District Passport and Population Registration Service (2005); expert of a Temporary Commission on Territorial Integrity Issues at the Georgian Parliament (2003-2004); Inspector of the National Central Bureau of Interpol (2003-2004); He founded Young Public Administrators Association and served as a chairman in 2001-2003. He is, also, the founder Georgian-Ossetian Cooperation and Development Center.

Dmytro Kaniewski. Born in 1982 in Kirovohrad, Ukraine. Studied at the English Collegium of Kirovohrad and after moving to Israel in 1994, graduated from Bosmat College at Technion University of Haifa majoring in Robotic Automation. From late 1990s and onwards he's been fully engaged in journalism starting his



career at Ukrainian radio network Radio Lux and further becoming a Middle East correspondent for Postup daily newspaper, Express and Lvivska Gazeta while cooperating with a wide range of Ukrainian media outlets. The latter include 5 TV channel, Ukrainska Pravda, Dzerkalo Tyzhnia, Vechirnia Gazeta etc. Since 2002 he has been working as a correspondent for both German International broadcaster Deutsche Welle as well as for the British based BBC World radio service. His most notable coverage includes the scandal surrounding the 2001 theft of Bruno Schultz frescos in Ukraine conducted by a group of researchers from the Israeli Holocaust institute "Yad Vashem", the uncover of the international organ trafficking criminal ring, which has led to arrest and sentences of those engaged in the affair, the cooperation of Ukrainian and Israeli historians on the Ukrainian Famine, Holocaust and OUN-UPA, as well as series of reports regarding the human trafficking from the CIS states to Israel and many other topics, which made into the top headlines in Ukraine, Israel, Poland, Russia and other countries. In 2008 Dmytro was anchored in DW bureau in Brussels, Belgium, where he was covering the EU and NATO affairs. Since then Dmytro has moved to Bonn, Germany where he is currently working as an Editor and Live Anchor for Deutsche Welle's Ukrainian Bureau.

Leigh Turner has been British Ambassador to Ukraine since June 2008. He began his career in the UK civil service in 1979 before joining the Diplomatic Service in 1983. Leigh's first overseas posting was Vienna, 1984-1987. From 1987 to 1991 he worked in London, and 1992-95 at the British Embassy in Moscow. In 1995-1998 Leigh was Deputy, then Head of



Hong Kong Department in London. 1998-2002 he served as a Counsellor EU/Economic in Bonn and Berlin. He took special leave 2002-2006 while his wife, also a British diplomat, worked in Berlin. During this time he looked after his two children and wrote novels and film treatments. He was also a journalist for the Financial Times and other newspapers. 2006-2008 Leigh was Director, Overseas Territories in London. His responsibilities included the Falkland Islands, St Helena, Bermuda and nine other territories. Leigh was born in 1958. He is married to Pamela Major. They have one son and one daughter.

Yuriy Yekhanurov is a Ukrainian politician who was Prime Minister of Ukraine from 2005 to 2006 and Minister of Defense from 2007 to 2009. Yuriy Yekhanurov was born in 1948 in the far-north Yakut ASSR, which is currently the Sakha Republic within the Russian Federation. Yekhanurov graduated from the Kyiv Construction College in 1967.



In 2005 Yekhanurov was appointed as a Prime Minister of Ukraine by President Viktor Yushchenko, after the President had sacked the previous Cabinet of Ministers of Ukraine. As part of the presidential quota of Ministers in the Ukrainian cabinet appointed in 2007 Yekhanurov became Minister of Defense. In 2009 he was appointed First Deputy Head of the Ukrainian Presidential Secretariat. Since March 2010 he has been the President of the Institute for Competitive Society, NGO. He holds a PhD-equivalent degree in Economics. He has also worked as Professor of Economics at National Taras Shevchenko University of Kyiv for the last 20 years.

José Manuel Pinto Teixeira became the European Commission's Ambassador to Ukraine in October 2009. Before occupying his current position, Mr. Teixeira worked as Ambassador and Head of the European Commission (EC) Delegation in Mozambique (2002-2005). In 1998-2002 he was



Ambassador and Head of the EC Delegation in the former Yugoslav Republic of Macedonia. Before that he worked as Head of the EC Mission in Bosnia-Herzegovina and Croatia, Counsellor and Charge d'Affaires for the European Commission Delegation in Angola, First Secretary of the European Commission Delegation in Swaziland, at the Bureau for Humanitarian Aid of the European Commission and at the Ministry of Foreign Affairs of Portugal. Mr. Teixeira graduated from the Portuguese Naval Academy, the Technical University of Norway (in Trondheim) and the London School of Economics and Political Science. He also received a degree in civil engineering at the Technical University of Lisbon.

Ukraine and Oxford

In the 20th Century, Oxford became one of the Western world's largest and most important centres for Slavonic Studies. In the years after the Second World War, with a great influx of government support, systematic collection of a broad range of materials related to Russia, Ukraine and other East European cultures began at the Bodleian Library, the Taylor Institution, and the Russian and Eurasian Studies Centre, established at St Antony's College in 1952. The Slavonic-related collections at the University's various institutions now number in the hundreds of thousands, covering such areas as history; politics and government; economics and economic history; literature and theology; sociology, statistics and demography; gender studies; geography and topography; bibliography, libraries, archiving and publishing; law; and general works of reference.

After the dissolution of the Soviet Union in 1991 and the emergence of an independent Ukraine, there has been a slow but steady growth in the number of students and faculty from Ukraine coming to Oxford to work and study. Today, there are 13 full-time Ukrainian students at the University, and five academic staff. There are also 38 Oxford alumni from Ukraine—including Sergey Evlanchik, an alumnus of Oxford University's Saïd Business School, who led his market-leading food company Ukproduct to become the first firm in the history of Ukraine to be listed on the London Stock Exchange.

For decades, Oxford has been Europe's premier location for major seminars and conferences on East European affairs, and has regularly hosted top academics and government figures from Ukraine.

There are also a number of research programmes and initiatives relating to Ukraine now ongoing (or recently completed) at the University of Oxford. These include collaborations with Ukrainian universities on the development of modules for teaching media law and press freedom issues; medical research on mortality rates from smoking over the last half-century in developed nations, including Ukraine; and a major three-year project in collaboration with Ukrainian research partners investigating social inequality and its consequences in post-Communist Eastern Europe.

The Fellowship

St Antony's College is one of the world's leading institutions for Slavonic Studies. The number of scholars in Slavonic Studies has increased to about fifty, and their distribution among colleges has widened. The Centre's prestigious weekly seminar is the longest-running forum in Britain, and among the oldest in the Western world, for the academic discussion of Russia and Eastern Europe.

St Antony's is now seeking to appoint a Research Fellow to run a programme on contemporary studies of Ukraine. The new Fellow will enjoy the excellent resources of the College's and University's libraries and the stimulus and support of one of the world's greatest scholarly communities. The duties of the Fellow will include:

- Research and publication of new work on Ukraine and its relations with Europe and Russia:
- Teaching master's students;
- Supervision of postgraduate theses on topics relevant to Ukraine;

 Organization of workshops, lectures and seminars to promote new scholarship on the subject.

Ukrainian students—they are amongst the most active in the College community and many are part of North the student-run University Ukrainian Society which has a lively annual programme. The work to progress and promote Ukrainian studies at St Antony's has been particularly notable of late with recent visits by the Ukrainian Ambassador, Dr Ihor Kharchenko, as well as the Deputy Minister of the Economy of Ukraine, Professor Natalia Boytsun, at the College. In the first instance, our fund-raising campaign is targeted at the creation of a five-year post. This will however be part of a long-term initiative to endow a permanent post and to create a larger and more diverse fund which will provide opportunities for scholarships and visiting scholars from the region. The key to progress in this initiative is to make a strong appointment in the short term.

Funding for the post

The cost of full funding for this post over a five-year fixed term is £550,000.

The Russian and Eurasian Studies Centre (RESC)

The Russian and Eurasian Studies Centre was launched in 2003 to carry forward the work of the internationally renowned Russian and East European Studies Centre, established in 1953. The Centre is a major area of research on Russia, Ukraine, the Caucasus and Central Asia at Oxford University.

Approximately half of all graduate students in Oxford who study Russia and Eurasia come to St Antony's. Many of its former students now occupy prominent positions in academia, politics, the higher reaches of personality of its own.

> There are four senior (Governing Body) Fellows at St Antony's involved in teaching and research in the field of Russian and Eurasian studies. Between them, the Centre Fellows cover twentieth century Russian history, Russian and Soviet politics and foreign policy, Russian literature and culture, and the economics of Russia, Ukraine and Central Asia.

St Antony's College

The College was founded in 1950 thanks to the generosity of the late French businessman Antonin Besse. Its first Warden, Sir William Deakin (formerly Winston Churchill's literary assistant and Churchill's man in Yugoslavia in World War Two), established its academic profile as the place in Oxford for the interdisciplinary study of modern history, anthropology, politics and international relations of the main regions of the world. St Antony's academics and students study the affairs of Europe, Russia and Eurasia, the Middle East, Japan, the rest of Asia, Africa, and Latin America. The College's Fellows are leading specialists both in a particular discipline, such as international relations, politics, history, economics or anthropology, and in the affairs of specific regions. More than 550 students from over 75 different countries study for postgraduate degrees at the College, and our alumni occupy leading positions in many governments, companies and international organisations. On this basis the College has built its world-wide reputation as a specialist graduate school, fully integrated into Oxford University but with a very distinctive
